- 1) At the SPG meeting held on 20 Oct., the Group provisionally agreed to recommend 11 project proposals for UNSCAR funding in the 2016-2017 cycle, subject to silence procedure until 31 October;
- 2) Shortly after the silence procedure, SPG's recommendation was submitted to the UN Trust Fund Manager for his approval and was approved on 7 Nov 2016;
- 3) Budget of selected proposals will be streamlined and revised in accordance with the UN financial regulations and rules as well as with the established practices of UNSCAR;
- 4) A grant agreement will be negotiated with each applicant, with the aim of initiating implementation from early 2017.
